Psorizide®Ultra Tablets

Read the Medication Guide that comes with **Psorizide®Ultra** before you start taking it and each time you get a prescription. There may be new information. This information does not take the place of talking with your doctor about your medical condition or your treatment.

What is Psorizide®Ultra?

Psorizide® Ultra is a biochemical homeopathic medication taken by mouth to treat moderate to severe eczema, atopic dermatitis, seborrhea and seborrheic dermatitis. It has been found to work well with a variety of combination therapies.

Who should not take Psorizide®Ultra?

- **Do not** take Psorizide®Ultra if you are pregnant, plan to become pregnant or become pregnant during Psorizide®Ultra treatment.
- Although there are no known contraindications, consult with your doctor prior to taking Psorizide®Ultra if you are allergic to any ingredients in Psorizide®Ultra. See the end of this Medication Guide for a complete list of ingredients in Psorizide®Ultra.

What should I tell my doctor before taking Psorizide®Ultra?

Tell your doctor if you have a history of kidney disease. The doctor will adjust the dosage.

Tell your doctor if you are pregnant.

Tell your doctor about all of the medicines you take including prescription and non-prescription medicines, vitamins and herbal supplements.

How should I take Psorizide®Ultra?

You must take Psorizide®Ultra exactly as prescribed by your doctor. It is important to take orally at the beginning of the day on an empty stomach, take nothing but water for one hour afterwards to avoid interference with Psorizide®Ultra absorption.

The amount of Psorizide®Ultra you take has been specially chosen for you. It is based upon your body weight.

Psorizide®Ultra may be swallowed whole, chewed or dissolved in the mouth.

If you miss a dose, just skip that dose. Do **not** take two doses at the same time.

If you take too much Psorizide®Ultra or overdose, call your doctor or poison control center right away.

What are the possible side effects of Psorizide®Ultra?

Psorizide®Ultra contains low doses of active ingredients. Therefore, there are minimal known side effects.

Tell your doctor if you have a history of contact sensitivity to nickel (common in metal) or if there is a history of vesicular hand eczema (dyshidrosis, pomphylox). Nickel sensitivity may be confirmed by a positive nickel patch test by your doctor. If you have nickel sensitivity, your doctor will prescribe a very low dose to start and then slowly increase your dosage over a 5 week period.

If you develop a rash, discontinue Psorizide®Ultra use and consult with your doctor.

How should I store Psorizide®Ultra?

- Store Psorizide®Ultra at room temperature, 68 to 77 Fahrenheit. Protect from light.
- Keep Psorizide®Ultra and all medicines out of the reach of children.

General Information about Psorizide®Ultra

Medicines are sometimes prescribed for conditions that are not mentioned in Medication Guides. Do not use Psorizide®Ultra for a condition for which it was not prescribed. Do not give Psorizide®Ultra to other people, even if they have the same symptoms that you have.

What are the ingredients in Psorizide®Ultra?

Active Ingredients: Potassium Bromide (Kali Bromatum) 1X, Nickel Sulphate (Niccolum Sulphuricum) 1X and Zinc Bromide (Zincum Bromatum) 4X. These drug ingredients are listed in the Homeopathic Pharmacopoeia of the United States (HPUS).

Inactive Ingredients: Lactose and Magnesium Stearate.
